- 775 transactions / £18.9k revenue 17/10/2018 to 16/10/2019
- Success for membership renewals
- Used for bus bookings, events and kit
- Feedback from Treasurer, and Membership Sec positive

Issues

- A minority don't support an electronic app
- 639 members! Management burden
- GDPR – especially if we rely on it for runner safety
- Clunky administration
- Scope – more than a membership sales/ticketing app
